

# Ph.D (Pharmacy) THESIS

Guidelines for participation in the competition  
for *PharmInnova Award 2025-26*



## **Eligibility criteria for participation:**

Following Colleges / Institutes / Universities can participate in the competition -

- All UGC approved Universities (Established under the UGC Act) offering full time Ph.D program in Pharmacy.
- Colleges affiliated with UGC approved University offering full time Ph.D. program in Pharmacy.
- National level Pharmacy Institutions (established & funded by Central Govt. - MHRD).
- Only those students who are issued Ph.D notification from their University / Registrar between **1<sup>st</sup> July, 2023 to 30<sup>th</sup> June, 2025** are eligible to participate in the competition.

## **Competition is restricted to the following three subjects of Pharmacy:**

1. Pharmaceutics
2. Pharmacology
3. Pharmaceutics Chemistry
4. Pharmacognosy

## **Procedure for participation:**

**Step 1** : Colleges (affiliated to UGC approved university) / University approved by UGC are required to submit their participation form duly filled, stamped and signed along with abstract submission form and full thesis. The participation form, abstract submission form and full thesis form are attached herewith and can also be downloaded from our website - [www.innovativethesisaward.org](http://www.innovativethesisaward.org)

**Last Date** : The participation form along with required supporting documents should reach us on or before 28<sup>th</sup> February, 2026. Request you to email the participation form (pdf) along with the required supporting documents at [pharminnovaaward@troikaapharma.com](mailto:pharminnovaaward@troikaapharma.com) Please note that the participation form will not be accepted if it is not accompanied with a copy of the approval document as mentioned in the eligibility criteria. (Colleges running full-time Ph. D. program - Please attach copy of affiliation letter & UGC approval of the University).

**Important:** Ph. D. Scholars, who have been issued Ph.D. notification from their University / Registrar between **1<sup>st</sup> July, 2023 to 30<sup>th</sup> June, 2025** as a full time student, are only eligible for participation.

**Step 2** : Our panel of jury members will select 1 winner in each subject.

**Note** : *In order to proceed with the evaluation, we must receive a minimum of three entries in each subjects.*

## **Evaluation and selection procedure:**

Our expert panel of jury members across India, will critically evaluate all submitted Thesis and then submit their evaluation report to us. Selection of the winner of the best Thesis will be on the basis of marks given by the jury members. Accordingly, an announcement will be made for the Winner in each subject.
